Decision Profile Model Church Bylaws Revision

Decision Required:

Approval by DEXCOM of a revision to clause 3.3 of the Model Church Bylaws.

Why It's Coming to DEXCOM:

Revisions have been proposed to the mandatory clauses of the *Model Church Bylaws* (MCB) template and therefore must come to DEXCOM for approval.

Background

Churches continue to make progress towards meeting the DEXCOM mandate passed in 2016 that all churches conform to the mandatory core of bylaw elements in the MCB. An update on organized churches completing this initial mandated bylaw review is below:

As work continues to assist churches in their required revision of their bylaws, it was felt that updates to the MCB were appropriate. The District Bylaws Committee recommends the revisions and additions listed by section below. The proposed revised version of the MCB is attached as D.13.1.

Part 3 – Government

Revision to clause 3.3 from:

3.3 NOTICE OF MEETING MUST BE GIVEN TO MEMBERS BY verbal and/or print media and/or electronic media (email, church website, etc.) AT LEAST twenty-one (21) days and not more than sixty (60) days PRIOR TO ANY MEETING OF MEMBERS. SUCH NOTICE MUST INDICATE THE PURPOSE OF THE MEETING.

To:

3.3 NOTICE OF MEETING MUST BE GIVEN TO MEMBERS BY verbal and/or print media and/or electronic media (email, church website, etc.) AT LEAST twenty-one (21) days and not more than sixty (60) days PRIOR TO ANY MEETING OF MEMBERS. SUCH NOTICE MUST INDICATE THE PURPOSE OF THE MEETING.

[The above bylaw clause 3.3 may only be used by unincorporated churches. From a wise governance perspective, churches are encouraged to use the alternate version of clause 3.3 for incorporated churches below.]

- 3.3 NOTICE OF MEETING MUST BE GIVEN TO MEMBERS BY verbal and/or print media and/or electronic media (email, church website, etc.) AT LEAST twenty-one (21) days and not more than sixty (60) days PRIOR TO ANY MEETING OF THE MEMBERS. SUCH NOTICE MUST:
 - a) INCLUDE THE DATE, TIME, AND LOCATION OF THE MEETING
 - b) INDICATE THE PURPOSE OF THE MEETING
 - c) If APPLICABLE, INCLUDE THE TEXT OF ANY SPECIAL RESOLUTION(S) TO BE SUBMITTED TO THE MEETING

[The above bylaw clause 3.3 is mandatory for incorporated churches. This is a requirement of the *Societies Act* of BC (77, 78).]



Rationale:

The Bylaws Committee reviewed the recent changes to the *Societies Act* of BC, and the revision addresses the current requirements for incorporated churches. Additionally, unincorporated churches are also encouraged to provide the same notice.

Recommendation:

THAT the revision clause 3.3 of the *Model Church Bylaws* be approved.
